- The company employs registered pharmacists to manage individual pharmacies. The company may also employ locum pharmacists. Our pharmacists are supported by fully trained staff.

CLASS 2 – WHAT WE SPEND AND HOW WE SPEND IT.

- All patients living in Wales registered with a general practitioner based in Wales are entitled to free prescriptions. No charge is payable for drugs or appliances supplied on a WP10 prescription.
- Charges are applicable to some patients presenting English FP10 prescriptions for dispensing in Welsh pharmacies, however many patients presenting English FP10 prescriptions may be exempt from prescription charges if they fall into certain categories. Full details of patients entitled to free English prescriptions can be obtained from the NHS UK website. www.nhs.uk. Telephone 111.
- All the pharmacies in the Avicenna group are contracted to provide NHS services. Full details of eligibility and remuneration for these services can be obtained from the NHS Wales Shared Services Partnership, NHS Business Service Authority or can be viewed using the online version of the [Drug Tariff](#).
- Information in this class will be published only where it does not and is not likely to adversely affect the commercial position of the firm or practice.
